Nestwatch Program: We purchase lumber, and volunteers build nestboxes (birdhouses) that attract bluebirds. We give a nestbox to each new member who joins in person (at a festival booth or event); and we sell nestboxes at a wholesale price, in order to distribute nestboxes throughout Texas and spread "Bluebirds across Texas... one nestbox at a time".

Education: We present one major educational event each year (Bluebird Symposium). We pay for the publication of Texas Parks & Wildlife's booklet, "Bluebirds in Texas". We publish an eight-page newsletter four times a year, and mail it to members who do not accept an electronic version. We rent space at festivals where we offer educational materials and a free nestbox to new members.
